MINUTE of ANNUAL GENERAL MEETING

Minute of previous meeting

The Minute of the Annual General Meeting held on 28th October 2024 (published on the Forum's website) was adopted without amendment. Proposed Phil Back, seconded James Kennedy, carried *nem con*.

Annual Report

Steve referred members to the Trustees' Annual Report document for details of the Forum's activities and achievements during the year.

Various points in the Report were highlighted and expanded upon:

- The *Paul Bishop Prize* for the best article to appear in *Scottish Local History* had been awarded to David Smale for 'The Incidence of Escapes from Stobs Prisoner of War Camp, 1915-1918' in issue 118.
- Thanks were expressed to the team supporting production of *Clish-Clash* Linda Clark, James Kennedy and Andrew Jones and to Don Martin for his editing and production of the 3 issues of *Scottish Local History* during the year.
- Special thanks were made to Phil Back, who has taken on leading the Forum's marketing initiative work, and Andrew Jones for leading the Linlithgow Walk & Talk in May.
- Andrew Jones is stepping down from being a Trustee and Hon Secretary at this meeting; Linda Riddell has volunteered to take over as Hon Sec for the coming year. Steve expressed appreciation of Andrew's work for the Forum over the last 4-5 years.
- There has been a good response to the adverts placed in the Edinburgh Volunteers Centre seeking volunteers to assist with various aspects of the Forum's work and administration. In addition to the new trustees being proposed at this meeting, other

individuals have come forward offering to assist in various ways. Carol Ettershank has taken over as Membership Secretary already.

Accounts for the year 1st August 2024-31st July 2025

Jan referred members to the Financial Review and Accounts presented in the Annual Report document. The £5,163 surplus compares favourably to the £3,981 deficit reported last year. However, most of the surplus (£5,070) is the result of an error by HMRC who paid the Gift Aid claim twice! HMRC's procedures have prevented the additional money from being returned, instead they have advised that the Forum should retain the funds to be offset against future Gift Aid claims. This could take up to four years, but HMRC have confirmed that we will not be charged interest whilst the funds remain with us.

Revenue is up at £23,677 compared to £12,820 last year; this is largely due to the Gift Aid claim, which covered the last four years (and was duplicated as aforesaid). There has also been a slight increase in memberships and, consequently, subscription receipts. Expenses have also risen from £16,801 last year to £18,514 this. Last year's figure included exceptional expense for the Forum Strategy Review workshop, this year's contains £2,300 for an advertisement in the National Trust for Scotland magazine as part of our new marketing strategy. (The magazine goes to 166,000 recipients and will have a much greater overall readership; we don't yet know how effective the advertisement has been in attracting new members.) Journal production costs have increased slightly, postage costs substantially. There was a balance of £31,348 at the bank at the end of the year (£5,070 of which relates to the HMRC overpayment), which represents a very healthy level of reserves.

Subscription for the year 1st October 2025-30th September 2026

Jan formally proposed **no** change from the current subscription rates for the membership year 2026-27, noting that the Forum's finances remain sound and of the need to encourage new members to join, which might be hampered by an increase. The motion was seconded by Steve and carried *nem con*.

Appointment of External Examiner

Jan formally proposed that Eric Brown be asked to continue to act as independent external examiner of the Forum's accounts. The motion was seconded by Steve and carried *nem con*.

Election of Officers and Trustees

Andrew took the meeting through the election of Forum Trustees and Officers. With Andrew stepping down from being a trustee and Hon Secretary there are 8 standing for re-election (4 having been co-opted during the year) and 4 new nominations. With no further nominations from the floor these 12 (the maximum number permitted by the Forum's Constitution) were duly proposed and seconded as follows:
